Supporting San Diego Families, Essential Workers with Children,
and the Child Care Ecosystem

Updated: September 11, 2020

The **San Diego COVID-19 Children's Fund** began March 13, 2020, by San Diego for Every Child, upon notice of school closures across San Diego County in response to COVID-19.

Conversations with school districts and community partners across the San Diego region surfaced three priority areas for children during this crisis time: **food and nutrition**; **child care**; and **equitable distance learning**.

Why Child Care?

- It allows our essential workers to do their jobs.
- It gives families flexible choices, ensuring their children a safe, enriching place of care.
- Child care providers operate 5,000 small businesses across San Diego County.
- It provides funds to family child care providers: an essential workforce caring for smaller groups of children, and a critical piece of San Diego County's overall economic recovery.
- It gives all child care providers--often among the lowest paid, essential workforce in our economy--the critical funds which are needed to keep their own children and families safe and fed during this uncertain time.



"I am a social worker and was notified by my program director that our outpatient behavior health... [was] deemed an essential service. I knew that I would need to continue working because unemployment would not be enough to provide for my little family. Once I heard about the CDA child care grant through a co-worker, I applied immediately. I was happy to find out I received the grant and it went directly to my provider. I maintained my employment without a lapse. My children and I are extremely grateful."

 - Diapers: \$3,300
 - Utility bills: \$3,450
 - Staff wages: \$5,175
- In health care alone, our region has an estimated 40,000 workers with children under the age of 14, which totals over \$30 million dollars in monthly child care expenses.
